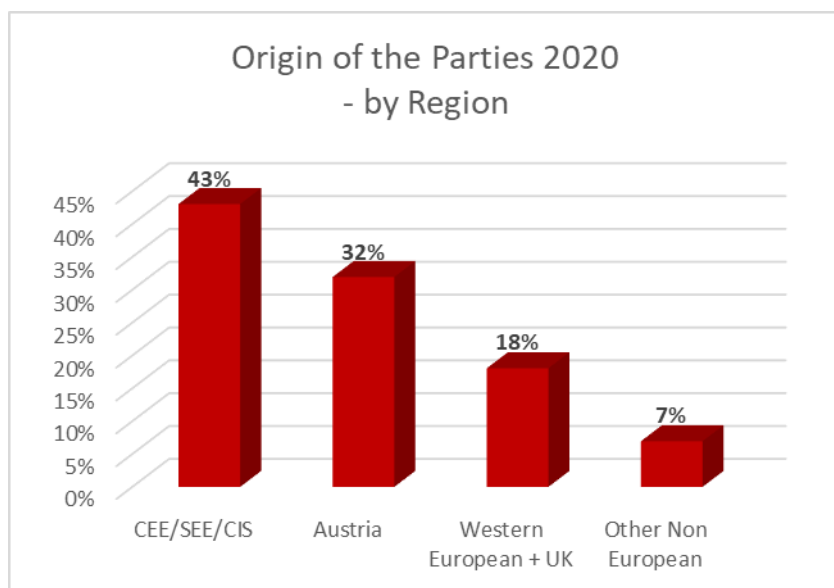

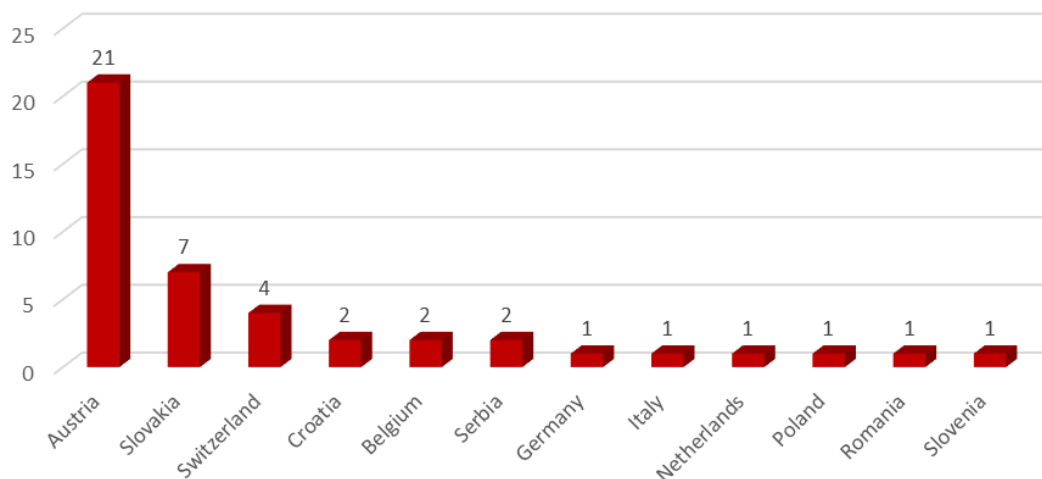

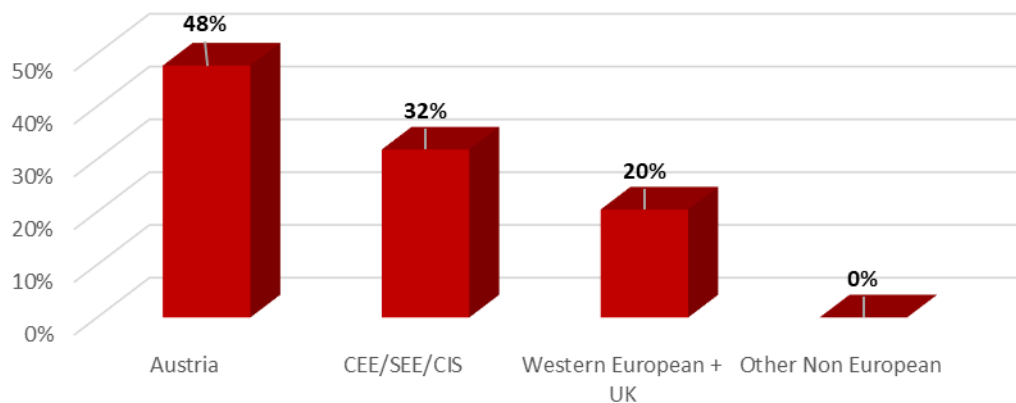

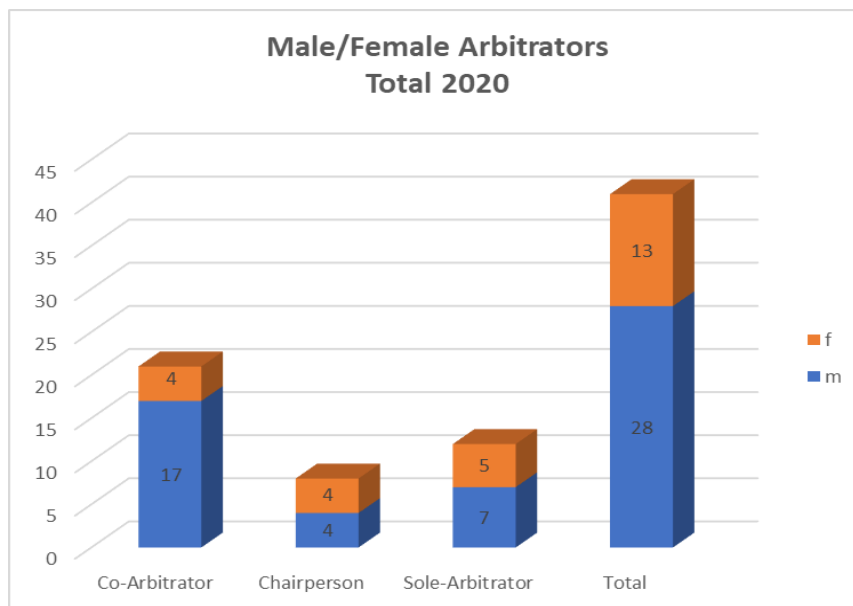
## Origin of the Arbitrators/Mediators 2020 - by Regions

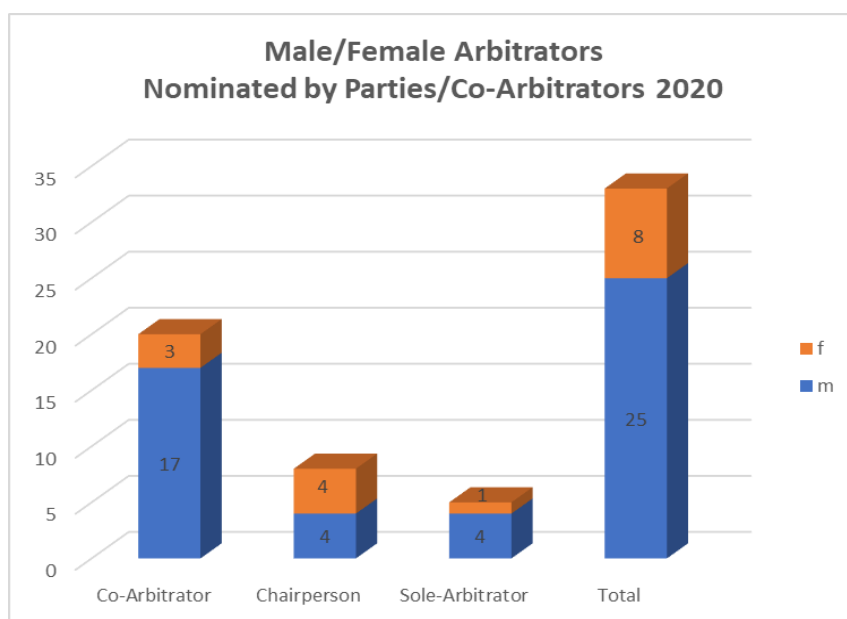
