

O. UNIV.-PROF. DR. BEA VERSCHRAEGEN, LL.M., M.E.M.

Bea Verschraegen was born in Ghent, Belgium. She moved to Austria in 1973 and studied law (and anthropology) at the University of Vienna. After having qualified for Comparative and Private International Law ("Habilitation"), she worked in 1992 as head of the Department "Europäische Integration" (European Integration) and deputy head of the Department "Europarat" (Council of Europe) in the Austrian Parliamentary Administration / International Affairs (Parlamentsdirektion / Internationaler Dienstbereich).

She was first-listed and offered a full professorship (C 4) for civil law and subsidiary subjects (Europa Universität Viadrina, Frankfurt / Oder, Germany), taught in the fields of civil law, private international law, comparative law, European integration from 1992-1994, and was vice-rector-designate for international relations. She was then first-listed and offered of a full professorship (C 4) for civil law, private international law, comparative law, European private law and European integration at the University of Bielefeld (succession Prof. H. Schack), where she worked from 1994-1998. Among other activities in Bielefeld, she was managing director of the Institute of Business Law (Institut für Wirtschaftsrecht, IWB, founded by Prof. Hommelhoff, University of Bielefeld). In 1998, she was appointed chair professor for private international law and comparative law with special regard to private commercial law (o. Univ.-Prof. für Internationales Privatrecht und Rechtsvergleichung unter Berücksichtigung des Privatwirtschaftsrechts) at the University of Vienna. Simultaneously to her professorship in Vienna, she was professor at PanEuropean University (PEU, Bratislava) from 2004-2014, vice-rector for international relations from 2009-2012 and special advisor to the rector of PEU from 2012-2014.

Her main areas of specialization include private international law, comparative law, private and procedural law, mediation, negotiation, counselling, and arbitration. She has been lecturing in a variety of countries and published widely.

Bea Verschraegen has assumed multiple tasks, i.a. representation of the Republic of Austria in the Commission Internationale de l'État Civil (CIEC, Strasbourg) from 1999-2000, 2002-2008. She was president of the CIEC in 2000-2001, and nominated "présidente honoraire" following her presidency. She was awarded the Russian "International Higher Juridical Prize ,Themis' 2014 "by the "International Fund for Support of Legal Initiatives" (Международный фонд для поддержки юридических инициатив) for special legal crossborder academic services. Throughout her academic career she served as head, member, expert and / or counsel in numerous councils, boards, committees, academic associations in Austria and abroad (i.a. the German Bundestag / Berlin; the Ontario Department of Justice (CA), senior expert in the frame of the project "Support to Civil code and Property Rights", managed by the EUO in Kosovo, etc). She has been expert advisor for i.a. the EU, the Council of Europe, the OECD, foreign research and development funds, Fulbright scholarship committees and reform projects (university reform of the University of Macau, Civil Code reform in Kosovo, development of the Master's Law Program at Sigmund Freud PrivatUniversität, Hague Conference, American Law Institute, development of the "Dispute Resolution Mechanisms for the Belt and Road" (Hong Kong). Since 2005 she heads the Section for Comparative Law, Unified Law and Private International Law, Faculty of Law,

University of Vienna. She was short-listed (final round) for the position of Secretary General of the Hague Conference (The Hague) in 2012.

She is i.a. titular member of the International Academy of Comparative law / Académie internationale de droit comparé and head of the Austrian Committee, member of the Academia Europaea, member of the American Law Institute and the European Law Institute, "ambassadrice" pour l'Autriche of the AiSDC (Lausanne), member of the International Advisory Board (IBA) of the CityU Hong Kong, fellow of the International Advisory Board of the "Belt and Road" Research Base of Hong Kong, member of the Austrian Mediation Council, member of the University Council of the Sigmund Freud PrivatUniversität (Vienna), member of the "Experts' Group on Recognition and Enforcement of Voluntary Cross-Border Agreements in International Child Disputes" (Hague Conference, The Hague), member of a range of national and foreign editorial councils.
